

- 1** - Access to the courses is reserved solely to the customers of Adventure Camp. Beyond these limits, access is strictly forbidden.
- 2** - Access to Adventure Camp is included in the paid fee which comprises:
 - Rental of self-protection equipment,
 - Instruction of safety techniques and availability of fittings.
 - The entry ticket is valid for 2h30/3h for the entirety of the course.
- 3** - Adventure Camp is open to adults, juniors, and children of 2 years of age minimum. Accompaniment by parent or adult-in-charge is obligatory for the duration of the activity for those of less than 16 years of age.
- 4** - By entering the course, all users accept, in their integrity, these rules and regulations.
- 5** - Only the self-protection equipment provided by Adventure Camp is authorized: cross belt, double halter, carabineers, and pulley. A form of identity will be requested at Reception. Any lost or damaged equipment must be paid for.
- 6** - All equipment is rented out for the duration of 2h30/3h. Participants determine themselves the conclusion of their activity.
- 7** - Before the start, instruction concerning safety and the handling of technical equipment is obligatory for each participant regardless of his /her level.
- 8** - At the start, the completion of the green initiatory course is obligatory. We reserve the right to refuse people judged unable to complete the course.
- 9** - Access to the blue, red, and black courses will therefore be authorized by the monitor. For these courses, activity is supervised but not guided. Participants progress autonomously.
- 10** - It is not obligatory to complete the totality of the proposed courses. Partial completion of the totality of the courses does not allow for reimbursement.
- 11** - Participants are responsible for the strict application of the safety instructions provided at the start and which are specifically signalled to them at each station and especially to remain attached continuously to the safety cable..
- 12** - One person per station, 2 maximum per platform.
- 13** - Any person exhibiting dangerous behaviour, creating a risk for him /her or for others may be excluded from Adventure Camp.
- 14** - Prohibited : deliberately swaying the stations, throwing stones, leaving behind papers or other rubbish harmful to the environment.
- 15** - It is strictly forbidden to smoke on the courses (stations and paths).
- 16** - Long hair must be tied back. Necklaces, bracelets, watches, or accessories (bags etc...) that may bother other participants must be removed.
- 17** - Each participant commits him /herself to not taking part if under the influence of alcohol, drugs, or medication that may impair alertness. Each participant also commits him /herself to be insured in civil responsibility.
- 18** - On pedestrian paths, children must be accompanied by and under the responsibility of an adult.
- 19** - VERTICALE PERSPECTIVE declines all responsibility in case of loss, theft, or damage to personal items during activity on the courses.
- 20** - In case of bad weather (rain, strong wind...) continued activity can become dangerous and must be ended. If this occurs before the end of the first hour, a free entry will be offered to each participant. However, beyond this time limit, VERTICALE PERSPECTIVE will not offer any reimbursement.
- 21** - VERTICALE PERSPECTIVE reserves the right to interrupt the activities of Adventure Camp if it judges that the safety of the participants is being compromised.

**For ancillary activities, a regulation is posted in the park at the reception desk and at the entrance of each activity.
